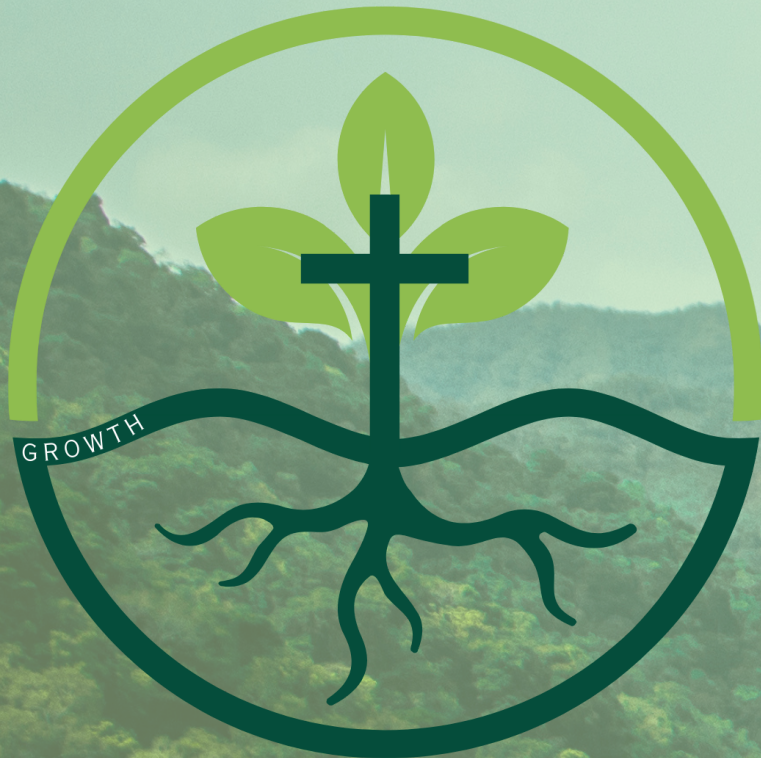

Due to risk management policy and procedure, we ask all churches for your assistance and cooperation with the following:

- Have applications **APPROVED BY CHURCH BOARD\*** (insurance purposes)
- **DOUBLE CHECK** for the Pastor's or First Elder's signature
- **PARENT SIGNATURE** if under 18 years old
- ALL LODGING IS **SHARED SPACE (BED)**. FEMALE WITH FEMALE AND MALE WITH MALE
- Please ensure to assign a **FEMALE AND MALE CHAPERON** per church
  - If you are bringing a large group to camp, please ensure there are **TWO** chaperones for both male and female groups.
  - All chaperones **UNDERSTAND** they will be **HELD RESPONSIBLE FOR THEIR CHURCH YOUTH**

## Rules & Regulations

- 1. RESPECT AND OBEY FJA MEMBERS, ASSISTANTS, AND CCF CAMP STAFF.**
- 2. FJA WILL HAVE A MANDATORY MEETING WITH ALL CHAPERONES REGARDING CAMP AND OTHER IMPORTANT INFORMATION.**
3. Those in attendance, if you are feeling under the weather, please consider other's health and wear a mask; temperature checks will be required if you show any signs of illness.
4. At the time of registration, you must **PRESENT A SCHOOL ID** or a **DOCUMENT WITH A PHOTO (I.D., Passport)** that proves your age to complete registration.
5. Campers **Without Application** or **Payment** will not be accepted. **APPLICATION IN NON-TRANSFERABLE. NO ACCOMMODATIONS. NO EXCEPTIONS. NO TRANSFERS OF CAMPERS. ALL APPLICATIONS MUST BE SENT IN BY MAIL TO FJA P.O. BOX.**
6. The use of jewelry such as rings, earrings, bracelets, chains, etc. is **NOT ALLOWED**. Please be aware of the weather conditions. Bring **MODEST CLOTHING, APPROPRIATE FOR SABBATH.**
7. Please use Christian vocabulary at all times. Refrain from profanity.
8. Please avoid distractions; do not bring handheld game consoles, radios, or other electronic devices. **FJA AND CAMP CEDAR FALLS ARE NOT RESPONSIBLE FOR LOST ITEMS OR STOLEN PROPERTY.**
9. Damaging private property on CCF campgrounds, including another camper's personal belongings, vehicles, etc., will remain the sole responsibility of the camper.
10. Please be respectful of the **NOISE LEVEL**. Please be mindful and respect **CURFEWS**.
11. Every camper should participate in the general programming, such as meetings, meals, and recreation.
12. **KEEP IN MIND THAT ALL LODGING IS SHARED SPACE (TWO GUESTS SHARE A BED, MALE WITH A MALE AND FEMALE WITH A FEMALE).**
13. It is **STRICTLY FORBIDDEN** to visit the **CABIN/LODGE ROOMS** of the **OPPOSITE SEX**.
14. **COUPLES** must maintain appropriate behavior and **AVOID BEING ISOLATED** from the group and away from the camp area.
15. Do not bring food into the rooms or cabins; remember, we are in the middle of the mountains, and there are animals that are attracted to this. Ex: Skunks, bobcats, mt. lions, raccoons, bears.
16. **THERE WILL BE NO ACCOMMODATIONS FOR MARRIED COUPLES, WITH THE EXCEPTION OF INVITED SPEAKERS AND FJA PERSONNEL.**
17. The participation of cleanliness and hygiene are required for each camper that resides within CCF campgrounds. Please be respectful of your roommates/bunkmates. Also, please throw your trash away properly, that includes the public restrooms, lodges, cabins, and shared spaces.
18. Firearms, knives, blades, explosives or flammable liquids, alcohol, cigarettes, drugs, the use or carry of marijuana, E-cigs, or any substance, are **NOT ALLOWED TO BE BROUGHT OR USED ON CCF CAMPGROUNDS** (It is Private Property). The possession or use of these items is dealt with seriously and, if necessary, will be reported to law officials.
19. **PETS ARE NOT ALLOWED.**
20. Applications of minors (15-17 years old) that are **NOT SIGNED BY THEIR PARENTS, PASTOR, AND OR FIRST ELDER WILL BE REJECTED.**
21. **EVERY CHURCH MUST HAVE A CHAPERON (LEADER) AND BE APPROVED BY THE CHURCH BOARD.**
22. Male and Female Chaperones must be indicated on the application by checking the box and adding the information to the application. If a big group is coming to camp, please assign two Males and or two Females as needed.
23. **ALL CHAPERONES UNDERSTAND THEY WILL BE HELD RESPONSIBLE FOR THEIR CHURCH YOUTH.**
24. No one will be allowed to leave the camp before departure time **WITHOUT WRITTEN PERMISSION OR REACHING OUT TO FJA staff MEMBER.**
25. The violation of one or more of the regulations may be grounds for expulsion from camp. The pastor and church board will be notified, and a report will be sent to the Hispanic Regional Director (Pastor Juan Osorio).
26. **FJA HAS THE AUTHORITY TO MAKE CHANGES TO THE ABOVE REGULATIONS.**
27. Campers with any medical conditions are responsible for bringing their medication. FJA is not responsible for any medication forgotten by the camper. It is the camper's (parent's) **RESPONSIBILITY** to bring their medication.
